- AND WHEREAS, the institution has by affidavit consented to come under New Regulations and sought for four basic units in B.Ed., which requires additional facilities.
- AND WHEREAS, it has been decided to permit the institution four basic units of 50 students each subject to fulfillment of the following conditions namely.
- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (I) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
