I am desired to inform you that extension in provisional affiliation has been granted to the Gyan Bharti College of Education, Vill.- Matak Majri, Tehsil- Indri, Post- Indri, Distt.- Karnal to run B.Ed. (Regular) course for the session 2008-09 subject to the fulfillment of the following conditions:

1. The College shall appoint qualified teaching faculty/Principal on regular basis as per Kurukshetra University Rules through the duly constituted Selection Committee and get the proceedings of the Selection Committee approved from the University before the commencement of classes.
2. The college shall fulfill all the conditions imposed by the Inspection Committee, NCTE and other allied conditions as per rules.
3. The College shall submit an affidavit on Non-Judicial Stamp Paper of Rs.10/- to the effect that 7 lecturers + 1 Principal (all eligible) are working in the College well before the commencement of the Academic Session alongwith actual joining of the teachers.

Kindly note that it is only provisional affiliation. In case the college is found deficient in infrastructural facilities/teaching faculty and/or acting in violation of University directions, Rules, Regulations, Ordinance etc., the college will be liable for penalties/disciplinary action including withdrawal of provisional affiliation.
